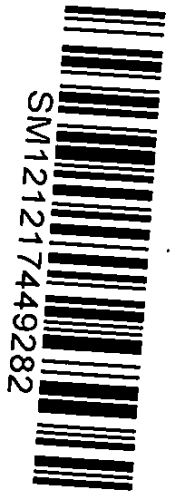

Companies Act 1965 as a private company limited by shares.

2. The business and registered address of the Respondent is at No. 23, Jalan

3. The amount of the total issued capital of the Respondent is paid up to

The Respondent is indebted to your Petitioner for the sum of RM1, 576,553.94 (Ringgit Malaysia One Million Five Hundred Seventy Six Thousand Five Hundred Fifty Three and Cent Ninety Four Only) being the total outstanding sum due and owing to the Petitioner for the final claim in respect of the works done for Kerja-Kerja Menaiktaraf Jalan Persekutuan 5 (FR 5) dari Tanjong Karang ke Sabak Bernam, Selangor ("the said Project").
6. A Letter of Demand dated 4.4.2019 has been issued and served to the Respondent by way of AR registered to the registered address of the Respondent. ("1<sup>st</sup> Letter of Demand").
7. Subsequently, another Letter of Demand dated 16.10.2020 has been issued and served to the Respondent by way of personal service to the registered address of the Respondent. ("2<sup>nd</sup> Letter of Demand").
8. Further, on 5.11.2020 another Letter of Demand has been issued and served to the Respondent by way of AR registered to the registered address of the Respondent. ("3<sup>rd</sup> Letter of Demand").

*Now produced and shown herein is copies of the Letter of Demand dated 4.4.2019, 16.10.2020 and 5.11.2020 and the returned AR card collectively marked as Annexure "B".*



9. A Statutory Notice dated 26.3.2021 has been issued to the Respondent pursuant to Section 465(1)(e) and Section 466(1)(a) of the Companies Act 2016 ("the Statutory Demand").

*Now produced and shown herein is a copy of the Statutory Demand dated 26.3.2021 marked as Annexure "C".*

10. Your Petitioner through its solicitors, Messrs S Ravenesan, had on 29.3.2021, served on the registered address of the Respondent by way of personal service, the Statutory Demand demanding the payment for the said outstanding sum owing to your Petitioner within twenty one (21) days from the date of service of the same.

*Now produced and shown herein is a copy of the acknowledged copy of the covering letter of the Statutory Demand dated 29.3.2021 marked as Annexure "D".*

11. Over twenty one (21) days have lapsed since the Statutory Demand was served upon the Respondent, but the Respondent has failed, refused and/or neglected to pay the said outstanding sum due and owing to your Petitioner or any part thereof or to secure or compound for it to the reasonable satisfaction of your Petitioner and your Petitioner therefore contends that the Respondent is unable to pay its debts and should therefore be wound-up pursuant to Section 465(1)(e) read with Section 466(1)(a) of the Companies Act, 2016.



12. In the circumstances, the Respondent is therefore deemed insolvent, unable to pay its debts and it is just and equitable for the Respondent to be wound up by this Honourable Court.

Damansara, No. 685, Jalan Damansara, 60000 Kuala Lumpur,  
be appointed as the Liquidator of the Company;

- (iii) The remuneration of the Liquidator shall be on a time-costs basis
